# INTRODUCTION

The intent of this agreement is to ensure that families of children with disabilities and/or developmental delays, who face numerous service providers and transitions, receive seamless transitions. This agreement is being expanded to ensure that all children have successful transitions in their early years. In Lake and Geauga County, Help Me Grow, Head Start, Early Head Start, Local Education Agencies, Starting Point, and the Lake and Geauga County Boards of Developmental Disabilities partner to ensure that children prenatal through five receive the best service and supports possible without experiencing a gap in their service delivery system.

When many service providers are involved, systematic procedures are needed to assure duplication of services does not occur and that gaps in services are covered. Transitions can occur at any point in service delivery. When unexpected or expected transitions occur, systematic procedures are also needed to assure continued support is provided to the child and family. Transition can be defined as a process for movement of young children and their families into, within and from service delivery systems. Transition is not a discrete event, and therefore, this agreement will need to continue to expand and change to meet the ever-changing lives of the families we serve.

# **PURPOSE**

The purpose of this agreement is to ensure interagency collaboration within Lake and Geauga Counties in the continuation of a comprehensive service delivery system and coordinated transition processes. Our commitment is to:

- Keep each other well informed;
- Avoid duplication of effort;
- Provide services that are of the highest possible quality;
- Ensure the needs and aspirations of families and children are at the center of each child's service delivery that is appropriate for each child;
- Promote the partnerships between and among the participants and the families they serve;
- Provide information and supports to families during the transition process to ensure effective participation;
- Respect the rights, opinions, and concerns of the diverse cultural population in Lake and Geauga Counties; and
- Implement a mutually beneficial, family-friendly system of transition.

This agreement specifies the roles and responsibilities of the participants and provides guidance for its continuation. This agreement is a "Work In Progress", recognized by all parties. The agreement has been written in accordance with the Joint Agreement between the Federal Region V & XII Administration for Children and Families, the Ohio Department of Education, the Ohio Board of Developmental Disabilities regarding Provisions of Services under Help Me Grow, and the Lake and Geauga County Family and Children First Councils.

# PARTICIPANTS RESPONSIBILITIES

Each participant agrees to continue existing responsibilities as required by the above AUTHORITY and to abide by any modifications in existing policy that may occur during the implementation of this agreement. Each participant agrees to participate in the overall coordination and implementation of services as outlined in this agreement. The Lake/Geauga CORE team, with representation from the LEAs, Head Start, Early Head Start, the Lake and Geauga County Boards of Developmental Disabilities, Family and Children First Council and Starting Point will continue to provide joint planning and oversight to ensure smooth, seamless transition process in Lake and Geauga Counties.

This Interagency Agreement will be in effect when all participants' signatures are secured and will remain in effect until a new agreement is signed. Help Me Grow and State Support Team 4 will maintain signatures on file. This Agreement will be reviewed at least annually and reauthorized in accordance with state and federal guidelines. Renegotiations of any portion of this agreement may occur at any time for good cause.

# CONFIDENTIALITY

Each participant agrees to abide by the Health Information Portability Accountability Act or the Family Educational Rights and Privacy Act, as applicable.

# AGENCY DESCRIPTION & RESPONSIBILITIES

# Lake County Board of Developmental Disabilities (DD)

Established in 1967 by the Ohio General Assembly, the Lake County Board of Developmental Disabilities serves 1900 individuals of all ages with developmental disabilities, through a variety of programs and services. The LCBDD's mission is to advance public awareness and to assist individuals to become valued and contributing members of their chosen community. Broadmoor School is the educational facility of the LCBDD and provides instructional and support services to children birth through 22 years with developmental delays or disabilities who are residents of Lake County. The Early Intervention Program is designed to assist families with children birth to 3 of age who have been referred by the Help Me Grow Program as eligible for Part C Services. The program offer evidence- based early intervention services with teaming ad coaching utilizing the Primary Services Provider Model (PSP) in natural environments, including home and community settings. The Early Childhood program offers integrated preschool classrooms that include children three to five years of age with disabilities and their typically-developing peers, as a part of the continuum of services available to families and Local Educational Agencies.

# Geauga County Board of Developmental Disabilities (DD)

Bessie Benner Metzenbaum Center serves children and adults with developmental disabilities such as mental retardation, autism, cerebral palsy, spina bifida, and traumatic brain injuries. The Metzenbaum Center offers activities and programs geared to maximize individual potential and encourage peak performance. The Metzenbaum Center provides a continuum of care for individuals of all ages, and has earned a reputation of excellence for its full complement of innovative programs - from a professionally recognized Children's Services, focusing on early intervention and community inclusion - to comprehensive Adult Services, including vocational training, community employment, workshop opportunities and senior programming - to Residential Services, offering intensive, on-site housing as well as attractive, community supported-living homes

# Head Start (HS)

Head Start (HS) is a comprehensive educational program funded through the Federal government, which serve children 3 through 5 years of age from low-income families. Lake/Geauga United Head Start, Inc. (LGUHS) operates the Head Start program in Lake and Geauga Counties. A variety of services are provided based on the child's individual needs. LGUHS directly operates a Head Start program in concert with delegate agencies. Head Start is mandated to make 10% of enrollment to children with disabilities identified on an IEP.

# Help Me Grow (HMG)

Help Me Grow is a program for Ohio's expectant parents, newborns, infants, and toddlers that provide health and developmental services so that children start school healthy and ready to learn. Services are designed with the families' concerns and goals in mind. **Help Me Grow** is the central coordinating site for the Help Me Grow services (listed below) in Lake and Geauga Counties. Help Me Grow services are funded through federal, state and local dollars.

**Specialized Services** (IDEA, Part C) provide developmental evaluations at no cost to the family; eligibility determination for ongoing specialized services; Individualized Family Service Plan, Service Coordination, Transition and linkage to community resources and family support groups and activities.

# **Early Head Start (EHS)**

Early Head Start provides early, continuous, intensive, and comprehensive child development and family support services to low- income infants and toddlers and their families, and pregnant women and their families. In Lake County, services are provided through a home- based program option.

# Local Education Agency (LEA)

A public board of education or other public authority legally constituted within a State for either administrative control or direction of, or to perform a service function for, public elementary or secondary schools in a city, county, township, school district, or other political subdivision of a State or for a combination of school districts or counties as are recognized in a State as an administrative agency for its public elementary or secondary schools. (34 CFR §300.18) Contact your local Board of Education for further information.

# **Starting Point**

Starting Point is a Child Care Resource and Referral (CCR&R) agency linked to the Ohio Child Care Resource and Referral Agency (OCCRRA) that connects families to programs and services that meet their children's early care/ education and related needs, and strengthens the community's capacity to respond to those needs.

A tool designed to support early intervention efforts to reduce emotional and behavior concerns by assessing risks in the social development of very young children.

Services that are designed to meet the developmental needs of each Part C eligible child and the needs of the family related to enhancing a child's development.

## ETR Evaluation Team Report

A report that is created to summarize the results of an initial evaluation or re-evaluation to determine whether the child is a child with a disability and is eligible for special education and related services.

## **DODD** Department of Developmental Disabilities

Lead Agency responsible for the implementation for IDEA Part C Early Intervention Services and Help Me Grow Program. The Ohio Department of Disabilities (DODD) oversees a statewide system of supports and services for people with developmental disabilities ad their families. DODD does this by developing services that ensure an individual's health and safety, encourage participation in the community, increase opportunities for meaningful employment, and provide residential services and support from early childhood through adulthood.

## FAPE Free Appropriate Public Education

Special education and related services that (a) have been provided at public expense, under public supervision, and without charge; (b) meet the standards of the State education agency; (c) include an appropriate preschool, elementary school, or secondary school education in the State involved; and (d) are provided in conformity with the individualized education program (IEP) required under section 614(d).

#### FCFC Family and Children First Council

Ohio Family and Children First is a partnership of government agencies and community organizations committed to improving the well-being of children and families. Created in April 1994 and mandated by the Ohio Revised Code (ORC 121.37) in 1997, the Council provides for a service coordination mechanism at the county level.

HV Early Head Start Home Visitor

Service provider for Early Head Start

IDEA Individuals with Disabilities Education Act (re-authorized in 2004 as the Individuals with Disabilities Education Improvement Act)

# IEP Individual Education Program

A written plan for a child with a disability that is developed, reviewed, and revised in a meeting annually. All services are determined though the IEP process with annual goals, objectives, and evaluation criteria determined by a team comprised of professionals and parents. The IEP for preschool children includes, as appropriate, how the disability affects the child's participation in appropriate activities

## IFSP Individualized Family Service Plan

A written plan for providing early intervention services to a child eligible under this part [34CFR303] and the child's family. 34CFR303.340

## LRE Least Restrictive Environment

Each school district shall ensure that to the maximum extent appropriate, children with disabilities, including children in public or private institutions or other care facilities, are educated with children who are not disabled, and special classes, separate schooling, or other removal of children with disabilities from the regular education environment occurs only if the nature or severity of the disability of a child is such that education in regular classes with the use supplementary aids and services cannot be achieved satisfactorily.

## **ODE** Ohio Department of Education

Lead agency responsible for the implementation of IDEA 2004.

## OSEP Office of Special Education Programs

Agency within the US Department of Education which is dedicated to improving results for infants, toddlers, children and youth with disabilities ages birth through 21 by providing leadership and financial support to assist states and local districts. OSEP administers the Individuals with Disabilities Education Act (IDEA).

# PCD Preschool Child with a Disability

Means a child who 1) Is at least 3 years of age and not age 6; and 2) Has a disability and who needs special education related services.

## **Procedural Safeguards**

Procedures, which protect the rights of children with disabilities and their parents with respect to FAPE, established and maintained by the State Education Agency (SEA). The Procedural Safeguards are contained within Special Education Procedural Safeguards Notice.

Individual who is responsible under IDEA for: coordinating the development and implementation of the IFSP; coordinating and monitoring service delivery; informing the family of advocacy services; coordinating with medical and health providers and facilitating the development of transition planning.

# SST-4 State Support Team 4

One of the Ohio Department of Education's 16 State Support Teams (SST) that serves school districts, charter/community schools and families in Lake & Geauga Counties regarding children at-risk and children with disabilities (ages 3 through 21).

## **TPC** Transition Planning Conference

An opportunity for families to prepare for the transition process by learning about their specific options for services, meeting with specific program representatives from the programs in which they might be receiving services, and to support families and children as they prepare for changes in programs and/or services.
