

This training will provide an overview of the required Learning Progressions for reporting in the 2016-2017 school year. Topics covered will include: purpose of the assessment, structure of the assessment, preparing for administration, using your current assessment practices to gather child information, scoring items, reporting assessment results, and using assessment results.

Description: The Ohio Department of Education is requires preschool special education teams to complete the Early Childhood Outcomes Summary Form (ECOSF) for all children receiving special education services. This training will provide an overview of how to complete the Child Observation Summary Form and provide resources to support teams in summarizing information about children.

Childhood Outcomes Summary (COS) Process Refresher

Description: Child Outcomes Summary (COS) refresher training will involve reviewing key features of the Child Outcomes Summary (COS) process and required information to successfully complete the process. Participants complete application activities and explore the requirements and resources specific to state policies about collecting child outcomes data. In this session, you will gain an understanding of: When to complete the COS process; Utilizing the decision tree, a tool to help distinguish between the ratings; How the 7-point scale is related to age-expected functioning; How to complete required forms; Effective COS teaming practices and how they lead to accurate ratings; How to support active participation by all COS team members, including families; and How to promote rich team discussions about a child's functioning.

FLIP IT lays the groundwork for teaching children how to problem solve difficult situations.
